1. Call to Order & Pledge of Allegiance – Commissioner Charles Duren called the meeting to order at 7:00 p.m.
2. Fire Evacuation Announcement

Present were Chairman Charles Duren, Commissioner’s Elizabeth Ballard, Alan Drinan, Peter Falk, Nicles Lefakis, Charles Ladd, Mary Scutt, and Alternate Commissioner’s Linda DeGray and Richard Szewczak.

Also present was Roger J. O’Brien, Director of Planning.

4. Approval of Minutes
 - a. January 21, 2016 – Commissioner Falk made a motion, seconded by Commissioner Ladd to approve the minutes of January 21, 2016. The motion passed with a 7-0-0 vote.

5. Staff Reports

Chairman Duren stated to Mr. O'Brien that the state came down because they are behind on some registrations and work was supposed to be being done on finding out who wasn't registered and sending out notices. He asked Mr. O'Brien if they got anyone to do this. Mr. O'Brien said that he did talk recently with the DEEP with respect to the application this evening. He said they also discussed the status of Enfield and he informed them that they are currently recruiting and advertising for additional town planners and once they have someone this will be there assigned task.

Public Participation

Chairman Duren asked if anyone from the audience would like to come forward and address the Commission. This was asked several times and no one came forward.

6. New Business

- a. AR #015 – New Aquifer Protection Registration application for 40 Moody Road, Map #75/Lot #27; Town of Enfield, Owner-Applicant.

Mr. John Cabibbo, Assistant Town Engineer, addressed the commission. He stated that he has come before the commission tonight to discuss the DPW complex at 40 Moody Road and register the activities going on there now in the Aquifer Protection. Also present was Deb Denfeld from Fuss & O'Neil who is very familiar with the complex who was there to help out with any details that needed to be explained. Mr. Cabibbo stated that the DPW complex has been there since about the 1960's or early 1970's. He presented to the Commission a picture of the current site as it is now and what types of regulated activities take place around the site. He stated one of the activities is the fueling station which is not only used by the DPW but also by another number of entities so this facility is used town wide. This application came up because the town was looking to put in a tank for emulsion; last year they bought some equipment called a durapatcher which uses an emulsion. Mr. Cabibbo stated that the durapatcher is only used during the winter for fixing potholes and the equipment was approved by Council. He went on to say that also in review of the site there are some future items that the town is looking to do; a truck wash and a covering or canopy over the fueling station. Mr. Cabibbo informed the commission that this application is for the registration of the existing activities some of which are salt shed, cold storage, fueling station.

Commissioner Ladd asked if the hazardous waste pick-ups are included in this application in case of spillage. Ms. Denfeld stated that it was.

Commissioner Scutt stated that the DPW is listed on the potentially contaminated sites for an underground tank that is possibly leaking and wanted to know if this was something they would be looking at. Ms. Denfeld stated that she knew the salt storage shed was listed on a DDP list for site potential contamination but generally any salt storage is added to that list. Commissioner Scutt said that they are listed as having leaking underground storage tank and shows as pending. Mr. Cabibbo asked what the time frame on this was and Commissioner Scutt said the list was last printed on February 10, 2014. Ms. Denfeld stated that work may have been done and just the paperwork was not closed out. Mr. Cabibbo said they could find out and confirm this was done.

Chairman Duren opened AR #015 to the public and asked if anyone from the audience would like to speak in favor or against the application. This was asked several times and no one came forward.

Chairman Duren closed public hearing AR #015.

Commissioner Drinan made a motion, seconded by Commissioner Ladd to approve Aquifer Protection Registration application for 40 Moody Road, Map# 75/Lot# 27; Town of Enfield, Owner-Applicant. The motion passed with a 7-0-0 vote.

7. Adjournment – Commissioner Falk made a motion, seconded by Commissioner Ladd to adjourn the meeting at 7:30 p.m. The motion passed with a 7-0-0 vote.
